Dear Principals, The Directorate General of Training (DGT), Ministry of Skills Development & Entrepreneurship (MSDE) has decided to provide an opportunity to all those government and private ITIs, who have already submitted their self-rating & who wish to correct/revise and resubmit their self rating ([www.itivtmis.gov.in](http://www.itivtmis.gov.in)). All government and private ITIs who have submitted the self-rating on or before July 31, 2017, are eligible to correct/revise and re-submit their self ratings till September 8, 2017. It may be noted that both - the originally submitted old self rating as well as the freshly re-submitted new self rating will be captured in the system. Re-submission of revised self rating is not required in case previously submitted rating is correct and is not required to be corrected. The ITIs has to mention the reason for the revision of the Self rating of their ITI in the column "REMARKS" available at the end of the Grading parameters.




