With reference to this office previous letter of even no. dated 06<sup>th</sup> June, 2019 on subject matter. In this regard, it is reported by State Directorates/ITIs that still there is some pendency for uploading the formality of hall ticket eligibility criteria & centre mapping on NCVT portal and hall ticket generation through portal. In order to avoid any inconvenience to the trainees, the competent authority has decided that NCVT MIS Portal may be open one more round as final for these activities as per the following schedule, so that all trainees of concerned ITIs may appear in AITT July, 2019 with NCVT MIS Portal generated hall tickets:-

In view of above, you are requested to strictly follow the specified dates and also ensure entry of hall ticket eligibility criteria i.e. Sessional marks / Formative Assessment marks, Examination Fees and Attendance of trainees by the concerned ITIs under your control, so that hall ticket generated from NCVT MIS Portal can be provided to all the eligible trainees to appear in AITT under CTS July, 2019 starting from **01.07.2019**.

**Candidates without NCVT MIS portal generated Hall Ticket should not be allowed to appear in exam.**
