## **ORDER**

In continuation to this office order no. 3949 dtd. 19.08.2019 Principals of the following three Polytechnics are hereby informed to contact the Principal of their allotted nodal center immediately for conducting Bio-Metric Registration of their 2019 admitted Regular & Lateral Entry students. If any regular/re-admitted student of the ongoing 3<sup>rd</sup>/5<sup>th</sup> sem is yet not registered in the Bio-Metric Attendance system then all such students should also be registered immediately. During Bio-Metric registration each student has to produce his/her ID proof such as College Identity card/ Aadhaar card/ Voter ID card or any other such document which has the photograph of the student, to the Nodal Officer for authentication. Principals of each private Polytechnic have to ensure that maximum no. of students are registered on a day i.e. minimum 200 students per day. However Bio-Metric registration of all students should be completed latest by 4<sup>th</sup> September 2019 without fail. Nodal center officers deputed for the purpose should contact the Principals of their allotted private Polytechnic and complete the registration process within the scheduled date. They must contact Mr. Sovan (9437501248) of NIC before proceeding to their allotted private Polytechnic.

Principals of all Polytechnics (both Govt. & private) are hereby informed to complete the Bio-Metric registration of their 1<sup>st</sup>, 3<sup>rd</sup>, 5<sup>th</sup> & 7<sup>th</sup> (PT) sem regular students within the scheduled date. If a student is not registered in the Bio-Metric Attendance system it will be presumed that the student does not exist and his/her name will not appear for any of the exam related activities in Vidyarthi portal. All Principals are once again reminded to collect the contact no. of their 1<sup>st</sup>, 3<sup>rd</sup>, 5<sup>th</sup> & 7<sup>th</sup> (PT) sem students and their parents and enter it in Vidyarthi portal through Student Registration (EDIT) option, under Registration link, for sending SMS. They are further reminded to collect the Undertaking from their 1<sup>st</sup>, 3<sup>rd</sup>, 5<sup>th</sup> & 7<sup>th</sup> (PT) sem students in the specified format enclosed at Annexure-1 latest by 31<sup>st</sup> August 2019 and retain it at their institute level. Thereafter Principals of all Polytechnics (both Govt. & private) have to submit the Undertaking to SCTE&VT, Odisha, in their institution pad exactly in the specified format enclosed at Annexure-2, latest by 11/09/2019 positively.
