

1.	(a) Upload of Sessional marks, Attendance and Exam fee of trainees for supplementary exam (all ex-trainees of semester system including August, 2018, Sem-I) and August, 2019 (Sem-I) as Final. (b) Upload of Formative Assessment marks, Attendance and exam fee for supplementary exam (all ex-trainees of Year-I) in annual system of exam.	03.03.2020 to 23.03.2020	By Principal of ITI as per attached schedule.
2.	Upload of centre mapping and generation of Hall Tickets through NCVT MIS Portal for semester system & annual system.	09.03.2020 to 27.03.2020	By State/UT Directorate as per attached schedule.
3.	Downloading of Hall Ticket from NCVT MIS Portal and issue to eligible trainees for semester system & annual system.	13.03.2020 to 08.04.2020	By Principal of ITI as per attached schedule.


