Subject: Popularising Mock Test APP for practice by ITI trainees

Sir/ Madam,

You may be aware that DGT has developed a mobile App for Mock Test for the Students and Trainers of Industrial Training Institutes, to effortlessly assess themselves and the performance of the students periodically. Almost all the ITI trades are covered in this Mock App in Ten different languages along with English. This mobile application aids in preparing the students and trainers for the upcoming CBT examination.

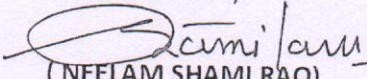
The Mock Test APP is available for free download from the Google Play store

The mobile app is packed with the following features

- a) Separate logins for students and trainers
- b) Easy registration with Student registration number and OTP verification in their registered mobile.
- c) Students and trainers are mapped to their ITI during login
- d) A very user-friendly interface is provided
- e) The test screen is similar to that which appears in the online examination has been developed
- f) Students can self-assess by generating their own question paper
- g) Option to generate a self-assessment question paper with 25 or 50 questions is provided.
- h) Every test generated is time bound with a decreasing timer showing the available time for completing the test.
- i) The mock test is timed at 30 minutes for 25 questions and 60 minutes for 50 questions.
- j) The exam automatically ends once the time is completed. The test can also be submitted by the student if he has completed all the questions in advance.
- k) Marks and performance of the students are displayed.
- l) Students can see the response sheet after completion of the examination.
- m) Students can re-attempt the same exam 5 times and analyse their performance in all the attempts.
- n) Trainers can generate a question paper for a particular subject and schedule an exam at a particular time
- o) An Exam ID is generated which will be shared by the trainer to all students in his group or class, for conducting the exam.
- p) The exam report is generated after completion of the examination in the trainer login.
- q) Bilingual question papers with the combination of English and regional language
- r) State directorates will be provided with a dashboard to monitor the conduct of exam and student performance.

You are therefore requested to circulate it to all the ITIs and direct the instructors to schedule a test for their trainees using the APP. State Directorates can also conduct centralized exams by generating question papers centrally and conducting the exam on a scheduled date and time.
