9	Publication of Final Grading and Ranking Report	27/03/2022



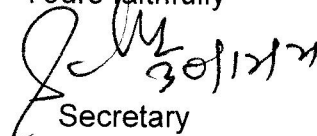

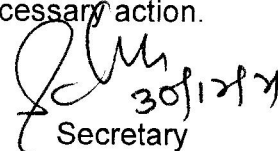

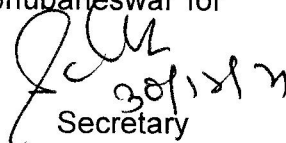
