You are, therefore, requested to kindly take immediate action for compliance of the judgment of the Hon'ble Apex Court as per Dr. Raghavan Committees recommendations No.s, 18, 30, 31 and ensure that all the Institutions under your administrative control have Anti-Ragging Committees to prevent the menace of ragging. Further, you are also requested to submit an annual report on functioning of the Anti- Ragging Cells, number of incidents reported during the academic session 2017-18 to 2021-22 and to take steps for sustained awareness campaign against ragging and give wide publicity against ragging. Action taken report in the matter may be sent immediately to this Department as well as to the MoHRD, Government of India for kind appraisal of the Government.
