Sub: Invitation of sealed quotations for supply of mattresses, pillow, bed sheet, carpet, temporary toilets, dustbins, drinking water container on hiring basis for State level ITI & Poly Fest'2022.

Sealed quotations are invited from Registered Firms / Tent Houses for supply of hired mattresses, pillow, bed sheet etc for State level ITI & Polytechnic Fest'2022 scheduled to be held during 27th February to 2nd March '2023 at Bhubaneswar with following ToRs:

- Hiring of goods & services:** - (a) Approximately 1000 sets, each set comprising of one white bed sheet, one cotton mattress, one pillow with cleaned cover on hiring basis for five days (b) Floor Dari approximately 5000 sft on hiring basis for five days (c) Approximately 100 temporary toilets/Green Loo (d) Safe drinking water in canes / dispensers / tanks of approximately 1000 Ltr per day with biodegradable glass (e) pedestal Industrial fans
- Selection of Firms and placement of Orders & delivery schedules:** The registered firms/ tent houses having valid GST, PAN / TAN numbers may offer their sealed quotations per set of mattresses per day basis for 5 days inclusive of taxes / charges with proof of registration numbers superscripted as Quotation for Mattresses for 'ITI & Polytechnic Fest'2022 should reach in the address of DTET Odisha, At- Kilamaidan, PO_ Buxibazar, Cuttack - 753001 on or before 17.02.2023 at 5.00PM. The selected firms shall be placed with hiring orders with actual requirement per day basis by 25.02.2023. The last date of delivery of all sets of mattresses & fixing of temporary toilets, dustbins drinking water container is 26.02.2023 by 2PM at ITOT campus, Sailashreevihar, Bhubaneswar as would be specified in hiring order.
- Payment conditions;** 30% of the approved quoted price shall be released as advance on placement of hiring orders for procurement of items, 60% after delivery of mattress sets in good / desired conditions and remaining 10% within 15 days of conduct of Fest.
- The quotations received beyond above stipulated date & time or not supported with required documents shall be summarily rejected.
- The authority reserves the right of accepting / rejecting any / all quotations without assigning any reasons whatsoever in nature.
