Sir/ Madam,

This is regarding employment status of the students passing out of Industrial Training Institutes (ITIs). The NCVET MIS Portal which is maintained by the Directorate General of Training, MSDE is an end to end portal which has the details of the students from admission to the examination and the result of exam. This portal also has a functionality of uploading the employment status of the ITI pass outs. The students passing out of ITIs are expected to upload the status of their employment on the portal.

However, it is seen that due to various reason this provision in the portal is not used and the portal is not updated. According to the data available on the NCVET Dashboard, it is seen that only 0.1 % of the students passing out of ITIs have got employment. This is not the case and these figures are not reflecting the correct picture of employment. Recently, the NITI Aayog has published a report on the functioning of the ITIs and the data from the NCVET portal has been used to reflect the employment status of the ITIs pass out.

As can be seen the NCVET MIS Portal is in the public domain and is used by various organizations / Parliamentary Committees etc, to gauge the relevance and functioning of the ITIs. Not uploading the correct data on the portal reflects a grim picture of the 'employment' of the student post ITI. Therefore, it is imperative that the portal reflects the correct picture.

It is requested that all the ITIs / students be directed to get the correct and updated status of their students passing out in the NCVET MIS Portal. In fact, some other options like students pursuing higher education or self-employed etc. are also being added to the portal.

You may also kindly direct all ITIs in your State including Private ITIs to designate a nodal officer in each ITI to update the placement data on the portal once in quarter.

It is requested that this being done on a mission mode and latest data on employment be updated on the portal by end of April, 2023. For ready reference a user manual on this functionality of the portal is enclosed.
